• Jan/San refers to the segment of Janitorial and Sanitation products. Pre-COVID-19, the segment size in the USA was estimated to be \$4.0 B.

 Given this is such a broad segment, it's expected that it's composed of various end-use segments and product classes/categories.

Floor-Care Products e.g., floor cleaners, waxes & finishes, floor strippers, etc.

Hand-Care Products e.g., liquid, foam & bar hand soaps, hand sanitizers, powdered & waterless hand soaps

Hard-Surface Products e.g., glass cleaners, toilet bowl cleaners, furniture polishes, disinfectants and sanitizers, drain cleaners, specialty cleaners, etc.

# The Immense Impact of COVID-19 on the JanSan Industry

- Demand exploded for hand-sanitizers, soaps, disinfecting wipes, and many other household cleaning products. These items were out of stock globally on retailers' shelves as well as online
- Several companies popped up overnight all over the world to keep up with the demand of hand sanitizers and other common cleaning supplies
- Many players in alternate segments like breweries and distilleries reconfigured their operations to produce and sell hand sanitizers instead
- In April, one agency estimated a 195% growth in the household cleaners' segment

# General Labeling Requirements for the JanSan Industry




- Due to the use of various chemical ingredients, the industry must comply with strict disclosure requirements on product labels and manufacturer websites
- Some states in the USA have imposed stricter disclosure requirements in recent years. This complicates the compliance efforts of manufacturers even further. Examples:


California Cleaning Products Right to Know Act

New York Envtl. Conserv. Law § 35-0103

- For cleaning commercial establishments and industrial units, OSHA imposes specific labeling requirements that apply when cleaning products are transferred to a new container. These requirements essentially mandate the use of a Hazardous Material Identification System (HMIS) label
- Due to ever-changing regulatory requirements, digital printers have been a preferred printing method in this industry to produce labels on-demand that are compliant with enforced regulations

- **5.** Due to the large amount of text information that JanSan product labels typically contain, a high print resolution is beneficial. Resistance to solvents and chemicals is usually another critical consideration. AstroNova's pigment-based printers (Kiaro!D) or toner-based printers (QL-300) will generally produce superior results compared to dye-based printers.

However, many key industry players have found dye ink solutions like the TrojanLabel T2-C, QuickLabel QL-850, or the QuickLabel QL-120X to be suitable enough for their standard applications. For extreme durability requirements, a tabletop finisher like the LF-100 or LF-200 can be used for protection via lamination.

For BS5609 compliance\*, it's strongly advised to use either the Kiaro!D or the QL-300 along with qualified media since any dye-based solutions will not meet the standard requirements.

\* **BS5609** is the internationally recognized British Standard for pressure-sensitive adhesive labels used for overseas shipping. Also known as the Marine Immersion Label Testing Standard, chemical manufacturers refer to this standard when their labels are used on hazardous chemical containers transported by sea.
